- **Global Charitable Organization:** helping 150 country representatives explore, understand, and achieve buy-in the need for a unified approach to how the organization did business and how to achieve that. Produced extensive report, worked with USA client project management team and led global facilitator team.
- **Market Transformation in Energy Efficiency Sector:** assisting project teams with numerous meetings related to commercial and residential building energy efficiency programs; assisted with strengthening collaboration efforts between utility members and not for profit organization whose mission is to accelerate the innovation and adoption of energy-efficient products, services and practices within the commercial, industrial and residential sectors.
